The committee has set itself three goals for this year 1) to raise the profile of the concept of an Elective Death 2) to support any VE candidate in the Federal election 3) to raise more money for the purposes of campaigning.

I have already been able to address the first goal this year through an invitation from The Canadian Atheist to write an article for them about the Elective Death model. The article will be published on March 10. I will ensure that it's also published on our website after that date.

For our second goal we have made enquiries about the VE Party's plans and discovered that it has no intention of running a candidate in the ACT because the likely outcome is highly predictable i.e. that voters will vote for the major parties. The Party's expectation is that candidates who want to run for the VE Party will have to fund and run their own campaigns.

We now know that the only party that has a pro euthanasia policy and has a chance of winning in the ACT is the Greens. There are now three seats in the ACT. The new electoral boundaries may be helpful to the Greens in winning a seat in the Lower House. From the vote in the Senate of the Restoring Territory Rights Bill we now know that a vote for the Greens is a vote for euthanasia and any bill related to it such as Territory rights. They have demonstrated that all Greens will vote as a party for any bill related to euthanasia. They are unambiguously in favour. They don't divide their numbers with conscience or free votes.

In the following table please note the candidates who have already been identified as standing for the House of Representatives and the Senate in the election this year.
